**Notes:**

1. Four inches per foot of vertical distance from the mean finished grade at the middle of the rear of the structure to the highest point of the main roof or parapet wall, **but not less than 15 feet.**
2. Three inches per foot of vertical distance from the mean finished grade at the middle of the rear of the structure to the highest point of the main roof or parapet wall, **but not less than 12 feet.**
3. Required under Section 405.3 for structures with free-standing wall; Otherwise none required, except under Sections 405.1, 405.2, and 405.6; **If provided, not less than 8 feet.**
4. Three inches per foot of height of building, **but not less than 8 feet.**
